

UT Game Tickets & Grande Communications Official Sweepstakes Rules

You must "Like" and complete the entry form in entirety on the Grande Communications Facebook page for a chance to win 4 tickets to the University of Texas vs. Texas Tech game (a \$400 value) on November 26, 2015. Deadline to enter is Monday, November 16th at 11:59 PM CST. Grande Communications will select a winner at random for those entries that "Like", "Share" and complete entry form. The odds of winning the prize are dependent on the number of entries that "Like", "Share" and completed entry forms during the entry period. Winner will be announced Tuesday, November 17th by 5 p.m on Facebook and winner will be notified through a direct email from Grande Communications. No purchase necessary to participate. Must be at least 18 years old and a resident of the state of Texas. Participants must have a valid email account, a valid Facebook account and Internet access in order to participate. Winner must provide their own transportation to and from the event.
